If this bid is accepted within the time stated, and we fail to commence the Work or we fail to provide the required Bond(s), the security deposit shall be forfeited as damages to the Town of Lac Du Flambeau by reason of our failure, limited in amount to the lesser of the face value of the security deposit or the difference between this bid and the bid upon which a Contract is signed.
- D. In the event our bid is not accepted within the time stated above, the required security deposit shall be returned to the undersigned, in accordance with the provisions of the Instructions to Bidders; unless a mutually satisfactory arrangement is made for its retention and validity for an extended period of time.



**1.08 CHANGES TO THE WORK**

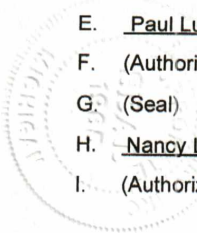
- A. When Architect establishes that the method of valuation for Changes in the Work will be net cost plus a percentage fee in accordance with General Conditions, our percentage fee will be:
  - 1. 10% percent overhead and profit on the net cost of our own Work;
  - 2. 8% percent on the cost of work done by any Subcontractor.
- B. On work deleted from the Contract, our credit to the Town of Lac Du Flambeau shall be Architect-approved net cost plus 0% of the overhead and profit percentage noted above.
