

RESOLUTION, NOTICE, AND LIS PENDENS NOTICE
TO DISCONTINUE PLATTED ALLEY

The Town Board of the Town of Lac du Flambeau, Vilas County, Wisconsin, by this resolution, adopted by a majority of the Town Board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

The Town Board pursuant to Section 66.1003(4)(a) having determined it's in the public interest to do so hereby introduces a resolution declaring an intention to consider the discontinuance of the platted alley located in Government Lot 3, Section 8, T 40 N, R 5 E, Block 3, Town of Lac du Flambeau, more specifically identified as "Platted alley to be discontinued lying between Lots 4, 5, 6 7 and 8-2 and 8-4 of the recorded plat of Gauthier Tract Subdivision." The alley to be discontinued is shown on the map attached to this resolution.

A public hearing to discuss the proposed action to discontinue the public way in the Town of Lac du Flambeau shall be held as provided in accordance with the following Notice of Hearing.

The Town Clerk shall publish the following Notice of Hearing as a class 3 notice under Chapter 985, Wis. Stats., and the Town Clerk shall cause the Notice of Hearing to be served on the owners of all of the frontage of the lots and lands abutting upon the public way sought to be discontinued in the manner provided for the service of summons in circuit court at least 30 days before the hearing, except that when the service cannot be made within the Town, a copy of the notice shall be mailed to the owner's last known address at least 30 days before the hearing.

**NOTICE OF HEARING - DISCONTINUANCE OF PUBLIC WAY
IN THE TOWN OF LAC DU FLAMBEAU**

A public hearing will be held by the Town Board of the Town of Lac du Flambeau at the Lac du Flambeau Town Hall, on Wednesday, July 10, 2019, at 12:45, to discuss a proposed action to discontinue the following described alley initiated by introduction of resolution of the Town Board of the Town of Lac du Flambeau under Section 66.1003(4) Wis. Stats., specifically:

That certain platted alley approximately 14' wide located between Lots 4, 5, 6 and 7, Block 3, of the Gauthier Tract Subdivision and Lots 8-4 and 8-2 in Block 3, of said subdivision Town of Lac du Flambeau. The portion of the alley to be discontinued ends at the NW line of Lot 4, extended to Parcel B-4. A map of the platted alley is on file with the Town Clerk.

The Town Clerk shall properly post or publish this resolution as required under Section 60.80 Wis. Stats.
