**EMS 5 Year Plan:** Members need to work on a 5 year plan at meetings. The need for schooling options needs to made available to obtain more volunteers. Discussions regarding equipment needs, also looking into the Oneida County Ambulance Contract.

An EMT pay proposal was presented by Chief Wegner. Per call pay to be increased from \$45.00 per call to \$50.00 per call. Pay EMT's \$5.00 per hour to carry a pager for a specific period. Shifts would be from 6:00 PM to 6:00 AM or 6:00 AM to 6:00 PM. Persons entering information into the WARDS program get paid \$5.00 per entry.
